The problem with the mafia and corruption in Bulgaria and in the European Union and the European Commission is huge. We have repeatedly applied evidence of the scale of this mafia. Based on this mafia and corruption in Bulgaria and the European Union and the European Commission, Lord Prof. Momchil Dobrev created in 2001. **4/. THE CASE**

4.1/. An individual, Radoslav Payne - a Bulgarian by origin, contacted an American company that had prepared to invest in the construction of an entire city on 4 million square meters of land around the city of Sofia - the capital of Bulgaria. The land is owned by the Dobrev Halachev Dynasty and is part of the Dobrev Halachev Dynasty Principality, which land both Prime Ministers Sergey Stanishev and Boyko Borisov have wanted to steal since 2008 by giving it - private land on concession with an illegal decision of the Council of Ministers.

On this land, in addition to the entire city, a 375 megawatt power plant based on the developments of Lord Prof. Momchil Dobrev, free energy generators, which would power the entire city for free, construction of an aquapark, construction of a research center, hospital, schools, kindergartens.

**The person states that he has engineers, architects and can provide any documents for this construction and investment.**

In return for the promise to develop not only a business plan but also all the documentation to be submitted to the Sofia Municipality. In return for this promise with a protocol receipt, Radoslav Payne receives an advance payment of thousands of dollars, euros, levs and even 435 grams of gold.

**This happens on the dates 06.03.2015 and 11.03.2015.**

The deadline for submitting the relevant documents is passing and apparently in order to gain time in the meantime, the person Radoslav Angelov Payne offers the Lord Acad. Prof. Momchil Dobrev is looking for clients to provide and ensure the issuance of original American passports and American driver's licenses, showing his own, issued on October 24, 2014 in Illinois Chicago with validity until October 24, 2024 and with an address in Chocago IL 60656 5441 N East River Rd. He offers the original American passports for a price of 15,000 euros, and the American driver's licenses for a price of 5,000 euros.

This offer gives rise to doubts in Lord Acad. Prof. Momchil Dobrev, that he will clearly be deceived because a Bulgarian who has never been to America and has been issued an American passport and an American driver's license, smells of actions that border on articles of the Criminal Code of both the United States and Bulgaria and which actually threatens the national security not only of Bulgaria but also of all member states of the European Union, since these persons with American passports can travel freely to enter and exit any of the countries of the European Union without being checked. And in reality, nothing is known about their real intentions, goals, aspirations and actions to carry out in the countries of the European Union.

After realizing that he had been deceived, Lord Academician Prof. Momchil Dobrev took action to inform the state authorities - then Prime Minister Boyko Borisov 2017 2019 and 2020, then Prosecutor General SOTIR TSATSAROV, as well as the American government, President OBAMA directly by letter and through the embassy in Sofia.

It all concerns lands owned by the Principality of the Dobrev Halachev Dynasty of the Dobrev Halachev Dynasty for which there is an appetite from the MAFIA THROUGH Prime Minister BOYKO BORISOV even when he was the mayor of the Sofia Municipality in 2008 and declared that these were his lands and he would build a city on these lands.

**4.2./.** Radoslav Payne's connection with the mafia in Bulgaria, headed by Prime Minister Boyko Borisov and prosecutors whose goal is the theft of the properties of the Dobrev Halachev Dynasty - Principality of the Dobrev Halachev Dynasty

It is no coincidence that in 2011, when Prince Lord Acad. Prof. Momchil Dobrev submitted to the Department of Architecture and Urban Planning of the Sofia Municipality all documents containing over 900 pages of a Detailed Development Plan for all lands over 4.4 million square meters - TWICE THE LARGER LAND than MONACO, the same documents disappeared and to this day no one knows where they are.

That is why RADOSLAV PAYNE's promise that there are people in the UAG and he will find the documents, which is just another lie and deception, since nothing follows.

Everything is to delay the reaction of the Dobrev Halachev Dynasty against lawlessness and the mafia both in the state and in the Sofia Municipality with Mayor YORDANKA FANDAKOVA at that time. And things begin.

On 04.04.2008. 21.05.2008. by virtue of decrees for assignment M.D. acquired two properties located in the Northern Tangent of the city of Sofia - the capital of Bulgaria, respectively with areas of 2050 decares and 2170 decares.

Already in September 2008, pressure began on the father by phone from 11 pm to 3 am, as DD was invited to donate the properties to the then Prime Minister BB and threats. After these threats, DD had a stroke, a heart attack and broke his leg in the hospital in Burgas. Since September 2008. DD has been bedridden in the city of Sofia.

After threats and extortion against the D. family failed, former State Security colonels posing as representatives of Prime Minister Boyko Borisov began to want to buy the properties at a price of 19,000 / nineteen thousand / times below the market price.

*After the refusal of this offer, actions were taken in various institutions.*

*Following letters from the Chairman of the Chamber of Private Bailiffs Georgi Saykov Dichev, to the National Revenue Agency, to the Chief Prosecutor Assoc. Prof. Boris Velchev and City Prosecutor Kokinov, the Sofia City Prosecutor's Office issued decrees by Prosecutor Mariyana Stankova from the Sofia City Prosecutor's Office to appoint tax audits against the entire family.*

*After colonels from the State Security 2010 and 2011 with an office on Vitosha Blvd. - a former police station - offered the D. family and are presented by the NAME of the Prime Minister BOYKO BORISOV and offer to buy these lands belonging to the D family at a price of 19,000 /nineteen thousand/ times below the market value ?!?!,*

*And after the members of the D. family refuse to sell these lands of theirs, the National Revenue Agency and the prosecutor's office are activated, tax audits begin, decrees of prosecutor Mariyana Stankova for tax audits, followed by foreclosures of all the properties of the D. family as well as the disputed lands of 2,050 decares and 2,170 decares.*

*The NRA is seeking unpaid taxes from the son of the MD family for 2,000,000 / two million / leva 6,000,000 / six million / leva, 48,000,000 / forty-eight million / leva, and then more millions of leva. Taxes in the amount of 2,000,000 leva are being sought from the father D, and 2,000,000 /two million/ leva from the mother, who have been retired for decades and do not carry out any commercial or other activities. Following a complaint from a person claiming to have the support of the GERB party and the DPS party, Krasimir Mollov, a prosecutor's file was opened.*

*In 2011, the apartment of the D family was set on fire, in 2012, at the beginning of the year, a bus was waiting for MD at his office to hit and crush him, but only passed through his leg.*

*So far, NINE ATTEMPTS TO ASSASSINATE MD and members of his family by THIS STATE-LEVEL MAFIA have followed.*

*But at the state level, the attempt to steal the property began with decisions of the Council of Ministers with Prime Minister SERGEY STANISHEV, who later became Chairman of the EUROPEAN SOCIALISTS in the EUROPEAN PARLIAMENT, and with Prime Minister BOYKO BORISOV.*

*With Decision of the COUNCIL OF MINISTERS No. 43 of 23.01.2009. with Prime Minister Sergey Stanishev and subsequently with Decision No. 69 of 15.02.2010 with Prime Minister Boyko Borisov takes a decision to conclude an ILLEGAL CONCESSION with the company "CELZIAN" on PRIVATE PROPERTY properties. The Council of Ministers has determined and given PRIVATE LAND - additional to the concession area of 2,928.5 in the amount of an additional area of 9,084 decares PRIVATE PROPERTY.*

*The first attempt by statesmen from the mafia to steal the properties of the Dobrev - Halachev Dynasty family was back in 2009 when the Council of Ministers with Prime Minister Sergey STANISHEV decided to grant private land on concession for 35 years to a company.*

*This entire concession is ILLEGAL, UNCONSTITUTIONAL, ILLEGAL, in violation of the laws of the state and a CLEAR CRIME under the PENAL CODE because the laws of any country in the whole world DO NOT ALLOW PRIVATE LANDS TO BE GIVEN ON A CONCESSION by the Council of Ministers to another private company.*

*THIS PLAN WAS IMPLEMENTED in April 2010 when the Council of Ministers with Prime Minister BOYKO BORISOV made a decision and concluded a contract for 35 years on private land on a concession to a private company.*

*THE GOAL IS THE THEFT OF PRIVATE LANDS, which back in 2008 the then mayor of Sofia Boyko Borisov declared as his own lands on which he would build a super city.*

*Then in 2008 the attempts to extort the D family to give away their properties to mafia statesmen began.*

*2010 -2011 representatives of a statesman who was imprisoned abroad through their representatives, colonels from the State Security, began to try to force D. to sell his properties at a price of 1900 / nineteen thousand / times below market prices.*

*2010 and 2011 the requests for a Detailed Development Plan in the UAGK of the Sofia Municipality for the preparation of a detailed development plan did NOT DISAPPEAR BY ANY MEANS and are still not in existence. There are projects there for the construction of a 375 Megawatt power plant based on the free energy generators created in 1991 by Prof. Momchil Dobrev.*

*And after the Dobrev Halachev dynasty refused to sell, in 2011 the ARNOLD OF THE APARTMENT in which I live and my father - on a bed and my mother would BURN LIKE TORCHES?!?! Why do the cops - investigators from the 4th District Police Department of Sofia, after coming, touch the evidence of the arson - small plastic bottles and other items - evidence WITH BARE HANDS?? AND THERE WAS NO INVESTIGATION!!! Or after they refuse to sell the properties, the 2012 bus waits in front of MD's office for 40 minutes to his office, TO RUIN ME? And no one investigates anything. As for the next assassination attempt carried out on 03.12.2017 at 20.43 - IT FAILS because MD is also trained by foreign services to protect himself from murderers. These people do not know that they are dealing with a man who has messed with dozens of COPS from State Security not only in Sofia, when MD returned from Germany in 1989, but also in West Berlin in 1985 - 1986 and has avoided death and in 1992 SAVED THE LIVES and FAMILIES of SEVERAL intelligence officers who were on the list of a "supposedly Bulgarian" representative of this list*

in a FOREIGN TURKISH embassy, after which dozens of Bulgarian intelligence officers were MASSACRED in TURKEY and other countries abroad.

On 05.04.2012, a request was made to Deputy Minister Valentin Nikolov by the GERB delegation of Minister President BOYKO BORISOV to cancel this illegally concluded concession on private land.

On 23.07.2012, a request was made to the Prime Minister Boyko Borisov of the Council of Ministers and the Minister of Economy, Energy and Tourism - Delyan Dobrev to terminate the illegal concession.

On 15.03.2013, a request was made to the Prime Minister MARIN RAJKOV of the Council of Ministers to cancel the Decision of the Council of Ministers No. 43 of 23.01.2009 and Decision No. 69 of 15.02.2010 and terminate the illegally concluded concession on private properties with an additional area of 2,928.5 to the concession area of 9,084 decares PRIVATE PROPERTY.

On 03.04.2013, A COMPLAINT – REQUEST has been filed with the Prosecutor General SOTIR TSATSAROV of the Prosecutor's Office of the Republic of Bulgaria for the initiation of criminal proceedings against the persons – former Ministers of Economy Traycho Traykov, Delyan Dobrev, Deputy Ministers Nikolov, Kharitonova, Miroslav Katsarov, former Prime Minister Boyko Borisov for a proven crime – concluding a concession agreement on PRIVATE LAND for 35 years.

On 12.08.2014, a request is made to the then MINISTER PRESIDENT PROF. DR. BLIZNASHKI of the COUNCIL OF MINISTERS to cancel the Decision of the Council of Ministers No. 43 of 23.01.2009 and Decision No. 69 of 15.02.2010 and terminate an illegally concluded concession for PRIVATE PROPERTY. It has been announced that losses of over 4 billion euros are being caused to investments on these private lands.

On 28.03.2016, American companies file a request for inspection TO THE ATTORNEY GENERAL SOTIR TSATSAROV, TO THE PRESIDENT OF THE USA - Mr. BARACK OBAMA and to the PRESIDENT JEAN-CLAUDE JUNKER OF THE EUROPEAN COMMISSION BECAUSE OF THE CLEAR AND PROVEN MAFIA at the STATE LEVEL - MINISTRY OF ENERGY and the MAFIA IN THE STATE - AT THE HIGHEST LEVEL - MINISTRY AND COUNCIL OF MINISTERS, AND INACTION OF THE MINISTER-PRESIDENT BOYKO BORISOV, in connection with a concluded contract for the concession of PRIVATE LANDS for 35 years, with the express purpose of stealing these lands.

MULTIPLE TIMES MINISTER PRESIDENT Boyko Borisov has been summoned to comply with the law - for more than 10 years now.

MR. MINISTER PRESIDENT BOYKO BORISOV has been referred to a REQUEST TO IMPLEMENT THE CONSTITUTION and LAWS OF THE EUROPEAN UNION – 9 dated 29.03.2016 with entry number 4461/02.

The Ministers of Energy do not check this concession agreement with the company “CELZIAN” OOD in connection with Decision No. 69 dated 15.02.2010 of the Council of Ministers, why are the fees not being paid, why are the relevant obligations not being fulfilled, why is this agreement not being terminated, especially since it is not being fulfilled, especially since it is a concession on PRIVATE LANDS in violation of the Constitution and all laws.

And this is in connection with failed investments for 5 BILLION US DOLLARS by an American company. In the registers of the Bulgarian National Bank, 5 billion US dollars of investment loans are registered, which will be used for the construction of an entire city, on an area of over 4000 acres of land, with all the amenities and prestige and luxury.

Moreover, on 04.04.2012, the deadline for commissioning expired, that the Council of Ministers took a DECISION OF THE COUNCIL OF MINISTERS No. 43 OF 23.01.-2009, DECISION No. 69 OF 15.02.2010 AND concluded an illegally concluded concession FOR PRIVATELY OWNED PROPERTY, and due to the fact that the Council of Ministers has determined and given PRIVATE LAND - additional to the concession area of 2,928.5 in the amount of an additional area of 9,084 acres of PRIVATELY OWNED PROPERTY.

Prime Minister Boyko Borisov and all energy ministers have requested the termination of this contract. Without any legal reaction from either the Council of Ministers with Prime Minister Boyko Borisov or his energy ministers.

There was no reaction from the President of the European Commission JEAN-CLAUDE JUNKER, and the entire European Commission, nor from the Prosecutor's Office with Chief Prosecutor SOTIR TSATSAROV.

In the complaints to the European Commission, it is requested to immediately appoint a continuous Monitoring of the state - the Republic of Bulgaria, you have already been provided with SUFFICIENT EVIDENCE OF THE MAFIA in the JUDICIAL SYSTEM - COURT and prosecutor's office in the Republic of Bulgaria and in the STATE.

For more than a year since 2015, the above-mentioned TWO COMPANIES HAVE BEEN EXPORTING Dobrevi's OWN EARTH IN THE DIRECTION OF "NORTHERN TANGENT" and UNLOADING IT THERE, IN RESPECT OF WHICH THEY RECEIVE MILLIONS.

Some of the trucks have the following numbers - of the company "PIMK" are:

ON 07.03.2016. MINISTER - PRESIDENT BOYKO BORISOV was personally informed, BECAUSE HE - DECLARED THAT HE IS FIGHTING AGAINST THE MAFIA AND CORRUPTION IN THE STATE AND EVEN ALLOWED HIMSELF TO STOP PUBLIC ORDERS FOR BILLIONS - INCOMING. NUMBER 4401/02 DATED 07.03.2016 – NO ACTION – NO RESULT.

NO RESULT. THE LOSSES ARE OVER 130,000,000 / ONE HUNDRED AND THIRTY MILLION / euros – THE VALUE OF THE LAND MASS and LOST BENEFITS AND PROFITS.

Prosecutors General SOTIR TSATSAROV and Prosecutor General IVAN GESHEV HAVE BEEN PERSONALLY INFORMED ABOUT THIS THEFT – WITHOUT RESULT.

The Ministry of Internal Affairs under Minister RASHKOV and Minister Deremendzhiev, appointed by President RUMEN RADEV as service ministers, have been informed.

EVEN THE NEIGHBORS THROUGH WHOSE PROPERTY THE THEFT OF THE LAND MASS CONFIRMED THE THEFT BEFORE A NOTARY - THEFT OF OVER 2,950,000 / dav million nine hundred and fifty thousand / cubic meters of LAND MASS.

Claims have been filed with the Council of Ministers personally, Prime Minister Boyko Borisov, the company PIMK", the company "GLOBAL WEST", the company "PIMK NVEST", and with the European Commission.

THE LOSSES FOR THE AMERICAN COMPANIES MANAGING THESE PROPERTIES are 130 million euros, from companies “ HIDROSTRIOI” near to prime minister BOIKO BORRISOV and company “ Vodstroi 82” NEAR to DELYAN PEEVSKI.

On October 30, 2023, before the court hearing in the case of Prince Lord Academician Prof. Momchil Dobrev in the Sofia District Court, he was warned by a counterintelligence colonel that on November 1, 2023, Dobrev would be killed in the Sofia District Court building, just as Plamen Penev was killed in Stara Zagora during detention with his head pressed to the edge of the sidewalk, as for Momchil Dobrev it would happen in the Sofia District Court building when he was held on the edge of the wooden bench on the second floor of the building, with the participation of judges, police officers and others on November 1, 2023 in the Sofia District Court building - Tsar Boris Blvd. 3 No. 52-54.

On November 1, 2023, Lord Prof. Momchil Dobrev has a court hearing against the Sofia Court of Appeal because Judge NELI KUTSKOVA abused her official position and, although she was taken to Momchil Dobrev's case against a construction company for losses of over 500,000 euros, she does not recuse herself but confirms the REPLACEMENT of SECURITY OF A FORBIDDEN IOT of Momchil Dobrev's DEBTOR - A CONSTRUCTION COMPANY that has not returned his money since 21.12.2007. REPLACEMENT OF THE SECURITY PROPERTY for only 2500 euros - i.e. MOMCHIL DOBREV is

guaranteed a LOSS OF OVER 500,000 euros, since the construction company no longer has any property after this act, and the non-return of the money and the non-transfer of property by the construction company has been proven by the PROSECUTOR'S OFFICE. I.E. MOMCIL DOBREV refuses to give his ID card, especially since he had changed his ID card at the police station a few days before. Immediately, Judge LYUBOMIRI IGNATOV picks up the phone and calls the court security.

Momchil Dobrev understands what is being prepared and that during this detention he will be killed ACCIDENTALLY and immediately takes measures to leave the Sofia District Court building, stopping 7 meters after leaving the court building. He is attacked by 5 police officers who start to squeeze his arms and body and forcefully take him to a courtroom on the second floor to continue the case in which MOMCIL DOBREV is a plaintiff. 5 police officers guard him in the hall. In front of the courtroom, 4 more police officers challenge him, but MOMCIL DOBREV remains completely calm for two hours and 54 minutes while the court session is taking place with the participation of a prosecutor, for whom this behavior of judge LYUBOMIRI IGNATOV is not illegal.

After the court hearing, Momchil Dobrev demanded the recordings from the cameras inside the court and outside the court from the ministers. Assoc.
