CREATION OF CONDITIONS OF DEPENDENCE OF THE BANKING SYSTEM OF THE RESPECTIVE COUNTRY ON THE RESPECTIVE BANKS OF THE MAFIA. AND ON FINANCIAL-BANKING RESOURCE-TECHNOLOGICAL MATERIALISM. On the banking institutions of EUROPE – Germany, Italy, France – USA – on the Rothschild Rockefeller families

Creation of a common military bloc – creation of the North Atlantic Treaty – NATO April 4, 1949. in Brussels and thus control and dependence of the security of all countries on the USA, of the military-industrial complex of Europe on the USA, creation of US bases in the countries of the union Germany.

Steps of creation, management and control of the European Union:

Completion – adoption of the model of integration with supranational institutions and as a result limitation of the respective national sovereignty

Creation of a common military bloc – creation of the North Atlantic Treaty – NATO April 4, 1949 in Brussels and thus control and dependence of the security of all countries on the USA, of the military-industrial complex of Europe on the USA, creation of US bases in the countries of the German union.

Steps of creation, management and control of the European Union:

Completion – adoption of the model of integration with supranational institutions and as a result limitation of the respective national sovereignty

Deepening – integration of new areas and gradual creation of an Economic and Monetary Union

Enlargement of the EEC – accession of countries with the obligation of the candidates to recognize and commit to and to take into account and observe the implementation of the entire fixed and legislative degree of integration.

The expansion is aimed at absorbing consumer, industrial and other markets, with the money ultimately returning to the countries – mainly Germany, France, the Netherlands and others.

3.1./ Historical sequence and evidence for the entire process of the formation of the European Union

3.1.1./ The capitulation of Germany

On May 7-8, 1945, the unconditional surrender of the German Wehrmacht was signed in Berlin-Karlsort.

On June 5, 1945, the victors officially announced that the highest state power in Germany had been taken over by representatives of the four victorious countries. and would be governed by them jointly.

Representatives were General Dwight Eisenhower (USA), Marshal Georgy Zhukov (USSR), Field Marshal Bernhard Montgomery (Great Britain), and General Jean de Tassigny (France).

THE CONFERENCES OF THE VICTORIANS OF THE WORLD WAR Tehran on December 1, 1943. at the second meeting held in Yalta on the Crimean Peninsula from February 4 to 11, 1945. , where the spheres of influence of the Soviet Union are consolidated,

At this meeting, the issue of reparations to be imposed on Germany is discussed for the first time. Stalin proposes a total amount of 20 billion US dollars, half of which is to be paid by the USSR.

From July 17 to August 2, 1945, the Potsdam Conference is held in the Cecilienhof castle in Potsdam. There, the details of the future joint management of Germany by the Allies, reparations, territorial issues are specified.

The Soviet Union must receive a "share" of industrial equipment and other reparations gains from the Western occupation zones.

We observe the dismantling of German industry, as well as a variety of reparations in the form of confiscation of part of the products of German factories for the benefit of the Allies.

There was a loss of markets, disrupted transport links, chain insolvency throughout the world, Germany has always exported industrial production and imported agricultural production.

In March 1946, a plan was announced for the dismantling of 1,800 factories and plants. As a result of the changed political situation in the world in August 1947, this plan was reduced for the British and American occupation zones.

The final list of factories to be dismantled was announced in October 1947. This included 682 enterprises - 496 in the British occupation zone and 186 for the American zone, for the French zone these were 236 German enterprises.

A total of 918 enterprises for the three zones.

The dismantling in combination with the Marshall Plan also had a specific effect. The dismantled were old factories and plants and equipment, after which new equipment and machinery were imported under the Marshall Plan, which helped production.

3.1.2./ Kanzleracte

Before that, there was a document that completely subordinated Germany to the USA, namely Kanzleracte.

Which existed from May 21, 1949. Which act is valid until 2099 - pt. 1. 150 years. This document was signed by the still unborn Federal Republic of Germany, which was created on May 24, 1949. on the one hand and the USA, England and France on the other hand - called "allies". The USSR did not sign this act.

This act states that every newly elected chancellor, even before taking the oath before the parliament, is obliged to sign the Chancellor Act, with which the "allies" legalize his election before the parliament and independently of it.

This Chancellor Act guarantees ownership and control over the German media until 2099. , Germany's gold reserves are in the possession of the allies until 2099. , . In reality, the USA is the leading country and France and England are just witnesses.

Finding Germany's gold as a pledge in the USA is a real tool for American racketeering, oppression, blackmail, coercion. This is a cut of over 120 billion euros.

That is, full control over Germany over the media, defense, finances is guaranteed., which means that Germany is deprived of state, military and financial sovereignty., capitulation of Germany over the USA for 150 years.

3.1.2.1. The Morgenthau Plan

The Morgenthau Plan, named after Hans Morgenthau, included the demilitarization of Germany, the destruction of the military industry, the fragmentation of 18 land areas, the destruction of the Ruhr as an industrial center,

the dismantling of all industrial equipment, the closure of all mines, the liquidation of large-scale agriculture, the temporary closure of all schools and universities, the confiscation of all aircraft, the deployment of international military forces, reparations, etc. The Morgenthau Plan was implemented only in the western occupation zones, but not in the Soviet zone. They dismantled 918 industrial enterprises / 368 of them were military, they banned foreign trade and limited imports, they banned sea fishing, the production of nitrogen for mineral fertilizers, they dismantled and destroyed 13 chemical plants, production fell by 82 percent, food by 65%.

They imposed a tax policy that allowed the United States to take 58% of Germany's gross domestic product.

3.1.3./ The Marshall Plan"

The real goals of the USA for the Marshall Plan are to save its industry and make the whole of Europe and the European countries, their production, finances, societies dependent.

The Marshall Plan was signed by President Truman by signing the decree on April 3, 1948. and continued until the end of 1951. with the USA pouring 13 billion US dollars, - in England - 2.8 billion, France - 2.5 billion, Italy - 1.3 billion, Germany - 1.3 billion, the Netherlands 1 billion

This amount of 13 billion is equivalent to 2019 in the amount of 156 billion US dollars

The situation as of 1947- for the USA is as follows:

The USA will export products and services for 16.2 billion US dollars. And the USA will import only goods and services for 8.7 billion US dollars. That is, the USA will deliver 7.5 billion dollars of goods and services in excess of exports. That is, these The rest of the world has to pay 7.5 billion US dollars, but it will not have anything, which will lead to a recession.

At the same time, at the end of 1946, the USSR refuses to open its markets to American goods and capital exports.

That is, the recommendation is that the United States finance the reconstruction of the industry of Germany and other countries, thereby ensuring that these countries buy US goods and services. The crisis in Germany and the interest of the United States in involving Europe in the reconstruction of the world economy strengthen the plans in early 1947 to create a program for the reconstruction of Europe. Cannon recommends a program "Coal for Europe" with which the production and distribution of coal in Europe will be improved, controlled, managed.

That is, there is a deficit of coal in Europe. For Europe, it means 36 million metric tons of coal.

France, Italy, Belgium, Denmark, Holland, Sweden and Norway will receive 40% of the coal from European countries, the rest from the USA, but they have no money with which to pay. European dollar resources are dwindling. Half of the cost of each ton of coal from the USA is ocean freight.

That is, the EU must restore coal production in Germany on the issue of steel in a document dated March 21, 1947. The shortage of steel in Europe, which limits progress in industrialization and industry, is caused by the shortage of coal. American steel mills cannot supply in both directions - for the domestic and foreign markets.

This will lead to a decrease in production and industrialization in the USA

The French are threatened that if they persist they will not receive a financial injection of the Marshall Plan in September 1950.

The Marshall Plan is officially known as the "European Recovery Program". European Recovery Program - ERP.

During World War II, the United States printed a huge amount of unsecured US dollars, the purpose of which was to use the same money to finance the reconstruction and construction of industry and the economy in Europe after the war.

The goal was for Europe to absorb the credits, loans, and become economically and industrially dependent from now on.

It is no coincidence that Churchill gave a speech in Fulham in 1946 when the "iron curtain" came down and the world was divided into a pro-Soviet part and a pro-American part.

In January 1947, the former chief of the US General Staff, General Marshall, became the US Secretary of State. In the form of friendly support - financing, This is the "Marshall" plan for "rebuilding Europe. The Marshall Plan even invited a country like Bulgaria and other countries from the encirclement of the pro-Soviet part, but it refused.

This concept is a continuation of the idea of US Secretary of War Stimson in 1945. . The ultimate goal is the implementation of the US strategy to organize European countries into a military bloc under the direct leadership of the US - NATO. This happens in 1949. on the one hand and the economic leadership.

Sixteen countries in Europe such as Austria, England, Belgium, Greece, Denmark, Ireland, Italy, Luxembourg, Norway, Portugal, Turkey, France, the Netherlands, Switzerland and Sweden their representatives on July 12, 1947. in Paris, to agree on the American plan.

West Germany is missing from the meeting, which will receive the most money, however.

Only Finland refuses to participate in the "Marshall" plan.

FROM 1944 The Bretton Woods Agreement was in effect, which guaranteed that one ounce of gold would be exchanged for 35 dollars. The parties agreed that they could always exchange dollars for gold. In addition, the Marshall Plan included a clause stating that 5% of the amount allocated to the country concerned would be directly allocated to the local administration.

By 1951, the amount of this 5% had exceeded half a billion US dollars.

The Marshall Plan began to be implemented on April 4, 1948, and continued until 1951. The United States poured in 13 billion US dollars during this period. . 2.8 billion were invested in England, 2.5 billion in France, 1.3 billion in Italy, 13.3 billion in Germany, and 1 billion in the Netherlands.

Countries like France are forced to buy coal at 20 US dollars per ton, provided that France can supply it for 12 US dollars per ton.

This is a repeated blackmail of European countries to buy US goods, with the profits going to the US,

Article 8 of the Marshall Plan Treaty obliges all countries like France, Germany and others to provide the US with "information about their economy and any other information".

That is, they report production secrets, secret secrets,

The goal is for European countries to trade with each other,

As a result, industry is modernized, industrial sectors are modernized in a short time. As a result, the economies of Western countries cope with the consequences of the war in a short time. This helps European countries to start paying their foreign debts - to the US.

The goal is not only industrialization, industries, etc., but also the removal of trade barriers.

The funds are directed to the countries of the newly created European Economic Community, without Spain, then General Franco is in power. As conditions for Italy and France is that they must expel all politicians with leftist beliefs.

The US conditions are requirements - for the money: refusal of nationalization of industry, granting freedom to private entrepreneurship, unilateral reduction of customs tariffs for imports of goods from the US, removal of communists from the government, restriction of trade with countries with a "pro-socialist orientation", etc. Profit for American business.

A huge European market has opened up for American companies, which needs raw materials, fuels, finished industrial goods / industrial equipment, - i.e. the aid is returned to American companies, which later happens in the EUROPEAN UNION AND THE EUROPEAN COMMISSION. As well as the fact that American companies invest in European companies invest their capital. I.e. Everything becomes subject to and under the command of American capital, production, etc.

For the coordination of the Marshall Plan, at the initiative of the United States, the Organization for European Economic Cooperation was created among the countries of Western Europe. This created a single market for the movement of capital, goods, and services. This organization laid the foundations of the "Common Market" in 1956. which is today the EUROPEAN UNION.

In 1947. it operated

LIBERALIZATION OF MONEY FLOWS - mainly from countries such as Germany, the Netherlands, Great Britain, France to poorer countries and ACCORDINGLY MONEY LAUNDERING in poor countries.

4. SUCCESSIVE STEPS

4.1. The Coal and Steel Treaty.

Whoever controls the industry and the production of industrial goods, the production of consumer goods, who produces the machines for the production of both industrial and consumer and food goods, controls the markets for all goods and services in Europe.

Steel is the basis for the industrialization of countries such as Germany and France. Industrialization is the basis of a society. The more fully and comprehensively covering all industries and sub-sectors it covers, the more powerful the respective country will be.

On the other hand, for the production of goods, products, services, energy is of vital importance for monopoly influence and defeating competition. That is why the first Coal and Steel Treaty is also signed.

Energy in Germany.

The goal is for Europe to absorb the credits, loans, to become economically and industrially dependent from now on.

That is, coal and steel are mutually dependent.

From here, as a result, the signing of the European Coal and Steel Community - ECSC between the countries of France, West Germany, Italy, Belgium, the Netherlands and Luxembourg on April 18, 1951 follows.

This is the logical consequence - unification of prices, standards, supervision of the market, monitoring compliance with competition rules and ensuring price transparency, free movement of coal and steel, free access to production sources,

The institution must ensure a normal supply of coal and steel on the common market, equal access to production sources, establishing low prices, free movement of goods without duties and taxes, prohibiting subsidies, state aid, special charges

In case of non-compliance with the rules, the supreme authority can impose fines / maximum 1% of turnover /, and penalty payments - 5% of the average daily turnover for each day of delay.

The ECSC budget contracts loans, collects taxes, guarantees loans to third countries,

In reality, the ECSC intervenes in government policies, manages the market, - monopolistic influence, fixes minimum and maximum prices in the ECSC frames. It supervises the issuance of licenses for imports and exports with countries outside the ECSC, determines the minimum and maximum rates related to steel and coal.

It also intervenes in cases of dumping.

By actually managing prices, steel and coal production, entire industries of these countries are managed.

As a final result, productions remain and are not closed, which are mostly in the territories of Germany of Arcelor-Mittal, Krupp, Thyssen Krupp, Belgium, France, the Ice Kingdom, Holland, Austria-Voestalpine, Poland-Mittal, Spain, Czech Republic and Sweden - SAAB, while everything possible is done to close and close real competitors from other countries.

As the real owners are in the same hands of those who remain to work and produce.

. That is, from here it follows not only the Marshall Plan for the restoration of the industrialization of Germany and Europe, but also that in reality this is a plan of enslavement by the USA and the bankers of the financial mafia.

Formally, the European Union is an independent legal entity, has the relevant powers and acts independently of the member states of the European Union. The status is regulated in the Treaty on European Union / TEU / and the Treaty on the Functioning of the European Union / TEU / entered into force on 1 December 2009.

The process is clear and proven.

4.2. NATO

Establishment of NATO - the North Atlantic Treaty on 04 April 1949. as part of the control and management of the countries of Europe and their involvement in the Cold War whose goal is investment and financing of wars, armaments, - i.e. maximum profit for decades to come, under the pretext that the USA and NATO will protect the European countries from attacks by the USSR and the socialist bloc.

Real dependence of the countries of Europe on the USA.

The main one is Article 55 of the Washington Treaty, which states: the parties agree that an armed attack against one or more of them in Europe or North America will be considered an attack against all of them and each party agrees that in the event of such an attack, by virtue of the right of individual or collective self-defense recognized under Article 51 of the UN Charter, it will provide assistance to the attacked party or parties by taking immediate action as it deems necessary, individually or jointly with another party, including the use of armed forces, to restore and maintain the North Atlantic region.

The reason is the Berlin blockade, which is used to force European countries that suffered from World War II to militarize Europe, and this militarization is once again in favor of the United States.

5. ACCESSION CONDITIONS profits from the acceding countries from Eastern Europe

Real drain of national income and wealth to the RICH COUNTRIES of the EU.

The goal is to close factories due to lower competitiveness CLOSURE OF PRODUCTIONS AND WHOLE INDUSTRIES to replace the supply of more competitive goods from DEVELOPED COUNTRIES.

The goal has been achieved - DESTRUCTION OF MANY PRODUCTIONS.

The principles of financing through European Union programs

RECEIVING FUNDS FROM VARIOUS EU FUNDS, including agricultural subsidies.

The analysis shows that usually 30-35% of the funds are paid in advance to consultants, designers and others who are mostly from the RICH COUNTRIES OF THE EU.

These are funds that are paid to consultants, expert designers and others.

RECEIVING FUNDS FROM THE EU and EC to improve competitiveness - in reality the money is returned to German companies mostly because the requirement is to buy machines, equipment, entire lines, production lines, the supply of machines is from GERMAN companies - mostly.

I.e. LARGELY THE FUNDS ARE RETURNED back to companies from the RICH COUNTRIES OF THE EU.
